## Winter PSSA Expression of Interest

Winter PSSA trials are in the final stages. Your child has shown a keen interest in being part of a Soccer or Netball team. Successful students at the trials will need to commit to attending 8.15am Friday morning training sessions along with travelling by bus to The Ridge Playing Fields each week. The season runs for up to 14 weeks (this is dependent on wet weather cancellations and finals).

PSSA is an extra curricula activity which incurs a fee. The school is unable to absorb the costs associated with student participation in PSSA competitions. Once teams are selected, the buses are booked for the season and costs finalised based on the number of students participating. There are no refunds for student absence on a Friday. Refunds will only be issued if games are cancelled due to wet weather.

The anticipated cost for the season is \$140 per student.

An initial payment of \$50 from each student will be required by Wednesday 1 May 2019 to indicate acceptance into the team. The final balance will be required by Wednesday 8 May 2019. Payments can be paid either online or in cash to the office. **Please do not send any money into school until your child brings home a letter of offer to participate in PSSA.**

Permission notes and code of conduct forms signed by both selected players and their parents/carers will be provided to those students who are selected and will also be required to be returned to the school prior to the season starting.
